What is a 'Competent Person'?

Under health and safety law, every organisation must appoint a 'competent person' to advise on the steps needed to comply with regulations and keep people safe. Depending on the nature and complexity of your business, this may involve one or more individuals with the expertise to identify risks and recommend sensible. proportionate solutions.

Do I Need a 'Competent Person'?

Yes. Regulation 7 of the Management of Health and Safety at Work Regulations 1999 (or the 2000 Regulations in Northern Ireland) requires every employer to appoint a competent person to assist in meeting health and safety duties.

While legal responsibility for health and safety cannot be delegated, most employers are not specialists — making competent advice essential. Appointing a competent person ensures that your business benefits from the knowledge, skills and professional judgement needed to protect workers, customers, visitors, and others affected by your activities.

Our Competent Person Service

The requirement to have a competent person(s) to support your organisation applies to all employers, regardless of size or sector. Although the regulations do encourage organisations (where practicable) to appoint a 'competent advisor' from within, this may not always be possible. For example:

- Due to ill health, parental leave, retirement or other circumstances where internal 'competent persons' are unavailable;
- To supplement the existing 'competent person(s)'; and/or
- Where the existing 'competent person(s)' do not hold the relevant knowledge to advise on a specific aspect of health and safety.

Occupational Noise Assessments

Understanding and managing workplace noise exposure is critical for protecting employee health and meeting legal requirements.

Team Arthian provides occupational noise assessments to:

- » Identify if exposures exceed the Lower [80 dB(A) LEP,d / 135 dB(C) peak] or Upper [85 dB(A) LEP,d / 137 dB(C) peak] Exposure Action Values.
- » Analyse Octave Band Frequencies and assess the suitability of personal hearing protection.
- » Conduct static and personal noise measurements, including octave, peak, and LEP,d readings.
- » Create noise maps around machinery and work areas.

All measurements follow the requirements of Directive 2003/10/EC and the HSE's guidance in L108 Controlling Noise at Work.

Our Capability

- » Hand-held sound-level meters: short-term readings, suited to stable/ repetitive noise sources.
- » Personal dosimeters: suited to long periods, up to a full working day.
- » Fixed monitoring: often used to monitor levels in a specific area where previous investigations have established that a level should not be exceeded.

Hand-Arm Vibration (HAV)

Exposure to hand-arm vibration can occur when using hand-held tools (e.g., breakers, grinders, lawnmowers). We assess exposure levels to help manage and mitigate risks of HAVS (Hand-Arm Vibration Syndrome).

Whole-Body Vibration (WBV)

Operators of machinery such as tractors, forklift trucks, and earth-moving equipment may be at risk from WBV, contributing to back pain and musculoskeletal disorders. We assess exposure to WBV to support safe working practices.

Breathe Easy: Indoor Air Quality Solutions

Poor indoor air quality can lead to Sick Building Syndrome (SBS), with symptoms including dry or itchy skin, headaches, lethargy, irritability, and respiratory discomfort. Symptoms often worsen with time spent inside and improve when away from the building (HSE Guidance Note HS(G)132).

We offer a full range of health, safety, and engineering services to assess and improve air quality, including:

- » Indoor air quality assessments

- » Temperature, Relative Humidity, CO and CO₂ Using a range of meters and data loggers, we measure indoor climate conditions.
- » Dust and Airborne Contaminants We sample for particulates and other contaminants using specialist air sampling equipment.

» Ventilation Rates

Using thermal anemometers, manometers, and vane anemometers, we assess ventilation performance against CIBSE, WHO, and Building Standards benchmarks.

» Light Levels

We measure illumination levels, ensuring compliance with recommended standards for different environments and tasks.
